4. New Church Construction Project

Bids were received for the site work on 6/12/2007 and opened on 6/13/2007. The bids were taken to the building committee of the parish and more information was requested. After providing the additional information there were still issues. The building committee needs to resolve any outstanding issues and award the site bid as this is delaying construction. Any members of the building committee who have reservations on the site work need to make their reservations known at the committee meeting because a decision must be made. The committee must also establish a procedure so that awarding of future bids will not be delayed. The parish council recommendation is for the building committee to meet as soon as possible. Based on this a meeting will be scheduled for Monday July 16, 2007. The committee should also plan to meet every two weeks thereafter to resolve construction issues that may arise.
