4. New Church Construction Project

New drawings were submitted to the township for approval. A mock up of the color scheme for the exterior walls will be presented to the building committee for comment. The sprinkler building will match the church as much as possible. Seventeen courses of block have been installed. Steel is expected in the next few weeks. All under floor lines are installed and approved and floor is poured in the classroom area and has been approved. Shop drawing for sprinkler building is 90% complete. HVAC drawings are complete. The last pole has been moved and the underground piping is installed. Street and parking lot curbing will be installed over the next few weeks. A liturgical committee has been formed and a meeting will be held Thursday April 3, 2008 at 7:30PM. All Parish Council members are invited to attend. All new furnishing will be needed for the new church as the current Church furnishings would not be appropriate. The Philadelphia diocese clearing house will be investigated to determine if we can obtain furnishings from this source.
