1. President's Report

The by-laws will be reviewed by the newly elected members of the council along with the secretary and changes will be submitted to the entire council for approval.

Father Joe reported that we will be planning a golf fundraiser sometime in October at the Peddie School followed by a dinner. Volunteers will be needed to organize and run this tournament.

3. Unfinished Business

Julie reported that 8 people attended the Spirituality Committee meeting. The meeting lasted about 2 hours with many ideas being presented. One idea is to have a web site to distribute information about spirituality events. Julie was informed to contact Mark Hoeler to set this up. The Spirituality Committee would like to have participation from the different church groups, i.e., Knights of Columbus, Rosary Altar and the Youth Group. Julie was advised to contact those organizations directly to solicit support. Spirituality Committee meetings will be on the third Tuesday of the month at 7:30 going forward. The committee believes that the new church will give focus to bring this ministry to all members of the parish.

4. New Church Construction Project

There is still no decision of what chair will be purchased for the new church. Cost and chair design is being evaluated. There are a number of alternatives being discussed. The meeting to choose the colors and materials with a large group of attendees went very well with selections being made by consensus. The construction of the building is progressing.
